The Bylaws Committee is recommending the following amendment to the Bylaws:

Revision is **bold underlined red**

ARTICLE IV

OFFICERS AND DIRECTORS AT LARGE

“The Officers and Directors at Large shall be elected by the voting membership to serve a two year term of office **or until such time as his/her successor is elected** as hereinafter provided. No officer or Director at Large

Rational: This addition will eliminate the problem with the legality of the last election since it is never possible to “suspend” the Bylaws. As time progresses, it would be advisable to do a periodic review since the organization is growing so rapidly.

NOTE: *In accordance with our bylaws Only Representatives from HOA members are eligible to vote.*
